The purpose of this public hearing is to allow citizens to provide comments and opinions on the proposed budget of the St. Landry Parish Sheriff for the fiscal year beginning July 1, 2024 and ending June 30, 2025. All persons are invited to attend regardless of gender, race, religion, handicap, etc.

Additionally, proposed amendments to the budget of the St. Landry Parish Sheriff for the fiscal year ending June 30, 2024 may be considered at the public hearing to be held on June 3, 2024 at 10:30 am in the Sheriff's Office.
